VOTER ID

Voters at polling stations now have show a **photo ID** to be able to vote. May 2nd 2024 and the Police and Crime Commissioner election may have caught some out, but from now on if you want to vote in person—and especially with the prospect of a General Election soon, and local elections next year, it is important that you have something to take with you.

Acceptable ID includes, driving licence or a 'bus pass, Blue Badge, or a passport.

University or College student IDs or work based ID's are not acceptable forms of photo ID.

Anyone who does not have one of

accepted forms of ID will be able to apply for free ID at: www.gov.uk [and search for "Voter Authority Certificate"] or by completing a paper form.

You will not need voter ID if you have a POSTAL VOTE.

We all know about the problems Shropshire
Council is having: including their latest wheeze, to axe the School's Library Service from 1st
September.

In the Local Council world (parish and town councils) whispers have been heard about local councils 'taking on' services (or parts of services) which the cash strapped Unitary Council cannot afford.

You see, while the BIG councils cannot legally increase Council Tax by more than a set amount [5% usually] we small, mostly independent councils can, if we wanted, could double or treble it, or if we went totally bananas, sting you for £50K. That would be bonkers, but it would NOT be illegal under the present laws.

Hence the whispers about 'if the service is important to you and your electors, would YOU like to run it, or pay US to run it for you?'

At the moment this is all talk, although one or two councils have been looking hard at how this might affect them.

In THIS area <u>your</u> ORPC is taking the lead, and hoping to get as many councillors from ALL the local councils around—Like Oswestry Town Council, Whittington, Gobowen, Weston Rhyn and the rest, together with our MP Helen Morgan, for a BIG meeting later in the year.

We want to see if we can hammer out some way to find a resolution to the potentially complicated matter of devolution, which holds on to what YOU value, but does not hit you too hard in the bank-

Many things will NOT change ----- EXAMPLES ----????


But with health finances as they are does it make sense – medically as well as financially – to try to duplicate everything on both hospital sites?

The medical staff don't think so – and they should know, and the new model of care was designed, led, and supported by clinicians.

The Royal Shrewsbury Hospital will specialise in emergency care from a dedicated, modern streamlined and effective emergency care service, delivered by the Emergency Department.

Patients will be seen more quickly, with faster ambulance handover times, and shorter stays there.

This should lead to patients benefiting from fewer cancellations and delays for those planned procedures.

Surely this can only be good for us all – whether we need a surgical procedure, or are involved in an accident, and our friends, neighbours and relatives?

The changes will [hopefully] transform health and care services across Shropshire, Telford & Wrekin, and mid Wales too.

The aim will be to improve quality, safety, experience and outcomes for people from across our large geographical area.



What is there for young people in the ORPC area to do?

The form-filling of 2 years ago may seem a long time ago, but some results are through the filter of the Office for National Statistics. Looking at those figures, the age profile of people in the Oswestry Rural Parish area seems to stack up with the general Shropshire result.

While for Primary school children, the percentages are almost equal, for the Secondary/College group they are not, and adding those two groups together, (10-19 years) the difference is even starker [Shropshire 10.6% - ORPC 11.7%]

And while there may be provision for the primary group, the question is: what is there for our secondary/college young people to do in the Morda and Sweeney Ward to do?

As Morda and Sweeney councillors, we would like to hear from our young people (10-19 years) suggestions about what the ORPC might be able to provide, promote or negotiate for them, the citizens of tomorrow!
