VILLAGE DESIGN STATEMENT

Over the last 9 months a group of residents have been working hard with updating the 2006 Trefonen, Treflach and Nantmawr Village Design Statement. (VDS). Key to the decision to review the VDS was that legislation, particularly planning, had changed potentially affecting it and local opinions and thoughts may have changed.

It is imperative with any community led initiative that it reflects local opinion. Initially the Steering Group asked for input from the original contributors and a cross section of local residents and produced an updated VDS for public consultation. This consultation took place during March and April this year. Comments were considered and included where appropriate. The resulting document is currently being reviewed by the Parish Council with the intention that the policies contained within the VDS are adopted. The next stage is to submit the document to Shropshire Council for their review and adoption.

ANNUAL PARISH MEETING 2016

On Tuesday 24 May the Annual Parish Meeting was held at Morda and Sweeney Village Hall. It was held on a different night to a Council meeting so to allow more detailed presentations to be given. The Chair of Parish Council, Matt Lee, opened the meeting with his report on the Parish Council. Because this has been a busy year Matt had many topics to report on. The Council has campaigned on behalf of residents on local issues, there have been changes in personnel both with the Clerk and Councillors and, more recently, collaboration on joint issues with Shropshire Council. Overall, the Council believes it now has the structure in place to assist and represent the Parish more effectively.

Three main presentations were given by the West Mercia Safer Roads Partnership, Shropshire Council and the Trefonen, Treflach and Nantmawr Village Design Statement Steering Group.

The meeting was attended by more than 30 people and concluded with an informal question and answer session.

COMMUNITY FUNDS

Shropshire Towns and Rural Housing (STAR) has a budget set aside each financial year for community based projects in areas where they have housing stock, this includes Oswestry Rural Parish. You can apply for funding up to a maximum of £500 by simply completing an application form.

Examples of eligible projects include: Educational workshops, setting up a residents group, leaflet drops, training and/or diversionary activities.

Your project should fall under at least one of the following categories:

- Safer such as extra security lighting
- Greener such as planting of shrubs/plants
- Cleaner such as litter bins/removal of graffiti
- United such as projects that encourage better relations between neighbours.

Automated External Defibrillators

We are very fortunate to have 3 AEDs located in the Parish. The AEDs in Trefonen and Rhydycroesau are supported by volunteers within their communities which means they can be used anywhere within 5km of their location. The Morda AED currently can only be used in public places. The Parish Council is looking to set up a group of volunteers to support the Morda AED. IN MEMORY OF MR VERDUN MORRIS

Last year a special service was held in the closed Trefonen Cross cemetery. Mr Frank Morris from Wrexham unveiled a plaque within the family memorial. The plaque was in memory of Mr Verdun Morris who lived in Trefonen and served in the Royal Berkshire Regiment. Mr Morris is laid to rest in Taukkyan War Cemetery Rangoon.

Those attending included members of The British Legion Oswestry (standard bearers), a bugler from the Light Infantry (Telford), Cllr Cheetham (Parish Council) and Mr F Morris' family and friends.



COUNCILLOR VACANCY

Being an effective councillor requires some work. The primary role of a councillor is to represent their ward and the people who live in it. Community Leadership is at the heart of modern local government and councils are taking on new responsibilities for working in partnership with other organisations, including Shropshire Council and the voluntary and community sector, to improve services and the quality of life for citizens.

THE BIG CONVERSATION

The Big Conversation, initiated in autumn 2015 by Shropshire Council, represents the beginning of a five-year conversation, with the people of Shropshire. Like all local authorities, Shropshire Council faces the challenge of needing to make substantial savings in the coming years due to the national effort to reduce overall public sector indebtedness. This means that Shropshire Council will not be able to deliver the same services to the same extent as they do now and there is an urgent need to prioritise how the budget will be spent in future.

Phase 1 of this initiative has been completed and key areas where funding should be protected and the importance of the voluntary sector and town and parish councils taking on greater roles have been identified. Oswestry Rural Parish Council will ensure it plays its part in seeking to protect services important to its residents and will be seeking your opinions at the appropriate time.
