1883 Chairman's Welcome

Cllr Peter Richardson welcomed everyone to the meeting and advised he was the acting Chairman in Cllr Martin Bennett's absence. He advised members Cllr Bennett continues to be unwell and wished him a speedy recovery.

Cllr Peter Richardson requested the variation of the agenda by bringing item 14 forward to item3. Members **AGREED** to this request.

1885 Co Option Application

Cllr Peter Richardson invited Mr William Jones to present himself to members. He gave an introduction as to where he grew up and that he is currently studying part-time in Derby. In terms of his application, he felt he could provide a perspective from the youth and a different viewpoint on emerging issues. Cllr Peter Richardson advised that members met on the last Thursday of the month and asked whether he had sufficient time to devout to the work of the Parish Council. Mr William Jones felt he was able to commit as he was only attending his course on a part-time basis.

It was PROPOSED, SECONDED and AGREED to elect Mr Williams Jones to the role of Councillor for the Morda & Sweeney Ward. There was one abstention. Cllr Peter Richardson invited Cllr William Jones to join the meeting by sitting with the other members present.

1886 Police Report

a)Cllr Peter Richardson advised members PCSO Charlie Ironmonger had sent his apologies for not being able to attend the Parish Council meeting and read the latest Police report provided by Oswestry Rural North Safer Neighbourhood Team.

b) Lack of Policing on Low Level Crime Locally

Cllr Martin Jones raised concerns with the lack of local policing on low level crime. He read the Policing Pledge for the UK setting out the standard of service which can be expected. He noted the 999 response time was under 50%. He commented that people should expect not to be treated as a stable revenue source (cash cows) through speeding offences or speed training courses. He believes early intervention by the Police at lower threshold is needed and provided examples of offences occurring locally.

The PCC newsletter stated Band D properties would see an increase of £280 a year for policing (5%). Improving visibility, access, better investigations and outcoming and increased public contact. He also noted the police would call time on retail crime although in Shrewsbury and Oswestry there are vigilante groups trying to stop shop lifting.

He noted the lack of attendance by the Police for this evening's meeting and expressed thoughts that the Police attending outside of Oswestry had little knowledge of the local area or issues. The is a lot of agriculture crime and low level drugs in rural areas. Early intervention and presence is paramount and low level crime must be taken seriously.

1887 Shropshire Council Report

Cllr Peter Richardson read the following report on behalf of Cllr Joyce Barrow

"The Council will have an overspend at the end of the year and will need to use its reserves, leaving an estimating two million pounds. Dangerously low. Sixty two million of saving need to be made by the end of the financial year. We will continue to look after and protect the most vulnerable in our society (adult social care/children's services)

In the budget savings, two recycling centres, will close. Those that remain open, will be only available to residents of Shropshire. At the moment, it is used by residents of Powys, Wrexham etc, whose authorities charge.

There will be a charge for green waste.

Some libraries will close. Some leisure centres/swimming pools will close.

As previously mentioned, there will be 300 full time job losses, as well as a large number of part time losses.

The council tax rate will be 4.9%"

Cllr Bob Kimber questioned why £6.2m was being sent on Consultants on how the Council can save money. There is a proposal of stopping transport for children with special needs. Cllr Martin Jones commented last month a Councillor had stated Shropshire Council would build a £25m leisure centre / swimming facilities.

He commented £10m had been spent on Mile end on a bridge and now there is going to be a shutting down of amenities. Cllr Peter Davies thought fly tipping in the countryside would increase with the closure of two recycling facilities.

1888 Public Participation

A representative from the Shropshire Union Canal Society thanked the Parish Council for its previous contribution towards the restoration works of the canal . He advised a stone pathway at Crickheath had been completed and volunteers had undertaken work over the Kings Coronation weekend. National Grid had donated money for the planting of hedgerow and Regional Prosperity money (match funding) has been received which will pay for the lining and preparation of the canal. The School House bridge should open shortly once work on a number of minor fixes is completed. There will also be the work in the future to link up the two missing miles of canal with Llanymynech.

1889 Minutes

The minutes of the ordinary meeting of the Parish Council held on 25 January 2024 were considered for approval. It was PROPOSED, SECONDED and AGREED that the minutes be APPROVED and ADOPTED as a true record. There was one abstention.

1894 Clerk's Report

Members **NOTED** a written report from the Clerk on action taken following decisions made at previous council meetings. Cllr Martin Jones asked whether funds had been set aside for HGV signage at Aston. The Clerk confirmed £3,000 had been set in the 2024/25 budget. Members **AGREED** for items 1606, 1796, 1796d and 1804 to be removed from the report. Cllr Martin Jones requested a print off of the planning leaflets. The Clerk confirmed that a letter and grant application was offered to a Trustee of Morda and Sweeney Village Hall at a meeting on 28 February 2024 and this had been refused.

1895 Financial Matters

Members considered for approval income and expenditure from January 2024, I & E Balances to date, and financial outturn position to 31 March 2024. The Clerk advised two minor changes had been made since finance papers had been issued. A slight increase on mileage and a reduction on postage charges.

It was PROPOSED, SECONDED and AGREED that the income and expenditure to 31 January 2024 and the balance of income received to date of £56,119.64 and gross expenditure to date of £57,878.64 be APPROVED.

Members considered the appointment of a Councillor to fill the Finance vacancy. Members **AGREED** to defer the appoint with a view to consider any future applicants who may have requisite experience.

- **e.** Cllr Peter Richardson advised members a number of website updates incorporating tabs for approved minutes and Environmental Working Group were required. The Clerk confirmed a cost of £90 excluding VAT . **It was PROPOSED, SECONDED and AGREED to APPROVE these update and charges.**
- f. Members **NOTED** a copy of the approved budget 2024/25

 It was **PROPOSED**, **SECONDED** and **AGREED** to **NOTE** the approved budget for 2024/25.

1896 Resignation and Vacancies

- **a.** Members **NOTED** the resignation of Cllr Roger Jones on 5 February 2024 and agreed for a letter of thanks to be sent for his contribution towards the work of the Parish Council.
- **b)** Members **AGREED** for the Clerk to advertise the vacancy in Sychtyn in accordance with current legislation and Best Practice. The Clerk confirmed this would be as a casual vacancy via Shropshire Council. Details of the process have been sent previously to members.
- c) Members considered the appointment of a Councillor to the Road Safety Working Group and Environmental Working Group as a result of the two vacancies caused by the resignation of Cllr Roger Jones. Members **AGREED** to defer this item to next month.

1897 Grant Policy

Members considered the revised Grant Policy which incorporated the changes agreed by members at the meeting held on 25 January 2024. These had been highlighted in yellow. Cllr Martin Jones pointed out the potential for the Parish Council to recoup grant funds not wholly used.

It was PROPOSED, SECONDED and AGREED to accept the revised Grant Policy incorporating changes agreed by members at the meeting held on 25 January 2024.

1898 Grant Application query by Morton Playing Field Committee

Cllr Peter Richardson advised members an email from the Chairperson of Morton Playing Field Committee had been received requesting the reasons for refusing an award of grant following the submission of an application for £1,500. Cllr Peter stated this had been discussed at length at the January meeting and the decision reached was based on it being considered an annual maintenance allowance rather than a grant. The amended Grant Policy limited grant awards to £500, apart for exceptional circumstances. This is to allow six different application to be considered. The Parish Council has no responsibility for this field and is aware most playing fields charge for usage which is then used to contribute towards annual maintenance costs. Sometime ago, the Parish Council offered to take ownership and maintenance responsibility for the field, but this had been declined. Members AGREED for the Clerk to send a response to the Chairperson of Morton Playing Field Committee stating the above and confirming no change in its decision.

1899 Environment Working Group

Water Pollution / Trefarclawdd Farm

Cllr Martin Jones provided an update to members on the water pollution tests copies of which had been sent out. A third set of tests along the River Morda had been undertaken and despite being heavily diluted the water pollution results were excessively high and again did not meet the bathing water quality standard. Cllr Martin Jones advised members that Cllr Iain Campbell had contacted the Environmental Agency with the regard to the ditch at Trefarclawdd Farm and heavy pollution from the water pollution test results.

Cllr Martin Jones advised he had received an email from Freedom Fibre concerning the roll out of fibre network across North Shropshire. Wayleaves and permission to work agreements give access to peoples' land and pylons can be built. He has objected to this previously and encourages people to lobby their MP.

Cllr Peter Davies commented that if the stream is polluted all the way down, it should be tested at various points to determine when the water was clean. Cllr Martin Jones advised it had been tested at source and found to be polluted. Up Sewage Creek have advised that almost all water courses are polluted at source beyond the legal level. In Shropshire, water pollution is caused by 50% farm run off and 50 % sewage. There are two spare tests available each month so if Cllr Peter Davies suggests a location, he would like testing this will be undertaken (location by "what three words).

c) Vyrnwy Frankton Connection

No update

1900 Coed y Go Speed Reduction Scheme

Cllr Peter Richardson advised members that an email had been received from the CIL / Section 106 Team at Shropshire Council asking for the Parish Council's view on whether to continue with the Coed y Go speed reduction scheme at the end of the Public Consultation period given the Police will be unable to enforce the speed limit. Cllr Peter Richardson reminded members that the West Midlands Constabulary objected to the speed limit, stating it would not enforce the 40mph speed limit through Coed y Go. The Clerk confirmed the Parish Council had contributed £8k of Community Infrastructure Levy funding to the design stage.

Cllr Martin Jones advised members the Police & Crime Commissioners and Safer Neighbourhood team talk held at Kinnerley, John Campion stated he would actively support traffic calming measures and speed reduction areas . This is also one of his top priorities for North Shropshire.

It was PROPOSED, SECONDED and AGREED to continue with the scheme.

1901 Oswestry Area Committee

Cllr Peter Richardson advised members he had attend the Oswestry Area Committee meeting. This was a short meeting due to a lack of members in attendance.

1902 Correspondence

a)Cllr Peter Richardson advised members a request had been received from a Morda resident requesting support for traffic calming measure along Kingfisher Way. Cllr Steve Watts advised members he was surprised by speeding given the stretch of road in question is no more than 100m long with a bend at either end. If speeding is an issue now it is likely to get worse given Kingfisher Way is a Cul de Sac. With the new housing estate being built in the middle ,Ashes Road and Kingfisher Way will connect at some stage. Cllr Martin Jones suggested speeding is by the residents that live there.

b)Members **NOTED** the Shropshire Council Medium Term Financial Strategy and Budget 2024/25 proposals. c)The Clerk advised that Councillor Martin Bennett in his capacity as Chairman has been nominated to attend the Buckingham Palace Garden Party on 8 May 2024.
