The more we grow, the bigger our influence in reducing speeds in our communities and making our roads safer. All our groups' activities are linked, so an offender in Herefordshire may be caught again in Shropshire, so followup action is swift and more robust.



New Look Community Speed Watch

We have recently made changes to the way we set up and support our CSW teams, with the focus on being more available to our groups and communities. These changes include clarifying the roles and responsibilities involved for both Safer Neighbourhood Teams and the Road Safety Team when setting up new CSW schemes and supporting existing groups. Here's a brief overview of what you can expect:

Safer Neighbourhood Team Liaison Officer

Point of contact for parish councils

Follow up initial enquiries

Conduct initial site feasibility study and speed survey

Manage vetting of volunteers

Liaise with Road Safety Team re risk assessments and training

Respond to group concerns and visit sessions when operationally able to.

West Mercia Police Road Safety Team

Responsible for site risk assessments

Carry out full speed surveys on site

Arrange training

Supply all equipment for new groups

Provide ongoing training and replace equipment as required

Process all offending drivers warning letters / police visits

Actively promote the CSW scheme



Your Community Speed Watch Coordinators

Marc and Mark would like to pass on their thanks to all groups for their continued efforts and for supporting Community Speed Watch, particularly throughout the Covid restrictions. The majority of teams returned to operational activity as soon as the restrictions were lifted by the government. As a result of the great work the groups had achieved prior to Covid, most areas saw little or no increase in speeding traffic when they resumed.

The pandemic has meant that some volunteers no longer wish to participate in the scheme, which we fully understand and we sincerely thank them for their work in helping to improve road safety in their community and wish them well for the future.

Pre-Covid, we had started to invite the traffic unit and local officers to attend pre-planned CSW sessions. We held numerous sessions in Cockshutt, Munslow, Marden, Newport and several other locations. These events were well-received by our CSW groups and local residents.

The Highway Code



The Highway Code changed on 29 Jan 2022.

Changes have been implemented to improve safety for people walking, cycling and horse riding.

The changes include new advisory measures that are not legal requirements, but could be drawn upon in court proceedings.

Staying Safe on Two Wheels

During April, West Mercia Police is supporting a national two wheel campaign, focusing on enforcement and awareness raising activity to improve safety for those on motorbikes and bicycles.

Police officers will be taking part in targeted operations to enforce compliance of road traffic legislation and improve driver / rider behaviour.

In addition to this, you will start to see 'Think Bike' and 'Ride Safely' posters appearing on key routes across the force area, encouraging all road users to share the road responsibly.
